We also included a requirement for the public to be notified of open member seats before the school year begins and elections are run. Elections will be held after the school year has begun.

  - Kimball High asked about the filter levels—students who are placed on a different internet restriction are having issues accessing content. Teachers are expected to embed content that is on a different website outside of Canvas to keep students on approved websites.
  - Content Keeper is a web filtering tool that only filters web searches. LanSchool Air has a resource that will restrict and limit apps and the searches available on that app.
    - Marielle Rawle will reach out to Scott McCombs to see if our school and district could utilize the LanSchool Air app restrictions.
  - Melinda Rosevear and Hailey Watanabe asked about the age of the lessons. Google's Common Sense Education is the authority that we pull lessons and content from. The age of these lessons are showing and we need updated information to share with community and to teach students.

#### Principal Report:

- Current year's LAND Trust/TSSP goals
  - No changes from our September meeting
- School data review
  - Data is still being collected and Jackie Ricks and Principal Rawle will be shared this information in a future meeting
  - We had 10% of our student population that attended. The district requires English Language Arts teachers to record the number of attended conferences
    - 9th and 11th grade had the highest percentage of parents who attended conferences.
  - Principal Rawle reached out to Butler Middle School to see how their conferences were held this year. Butler Middle School focused on supporting students who are struggling and parent education. This year, Butler's conferences were not attended well. We are looking for additional ideas and solutions.
- Attendance policy implementation update
  - Our Positive Behaviours Intervention Supports (PBIS) committee wanted to give rewards monthly for students who have no "attendance hold" on their account. The school is catching many more students who are responding to the incentive and rewards to work on their attendance.
- Celebrations
  - State Tennis is this week
  - Boys' State Golf – we took 6th overall
  - Theatre–Shakespeare Competition went very well. We took 2nd place overall in our division. We had three students who took 1st place—a first for Brighton in the last 10 years. Our Ensemble activity took 3rd overall.
  - Unified Soccer is playing this week at the REAL Salt Lake stadium. Brighton will have three teams who continue in the competition.

#### PTSA Report

- Conferences went well – we had new members who joined and merchandise sold for fundraising

#### Faculty Report

- Jackie Ricks – the Professional Learning Community (PLC) planning day went very well with our Math teachers creating a project-based learning activity. A lot of Brighton staff took the opportunity to visit the teachers and see student work.
